FAST-41 Covered Sediment Diversion Project Receives Federal Approval



The Permitting Council is excited to join with the Louisiana Coastal Protection and Restoration Authority (CPRA) to announce the completion of the environmental review and authorization process for the <u>Mid-Barataria</u> <u>Sediment Diversion project</u>. This FAST-41 covered project is focused on restoring Louisiana's Barataria Basin, which is experiencing some of the highest levels of land loss in the country, threatening the welfare of residents and the local ecosystem.

Sponsored by the Louisiana Coastal Protection and Restoration Authority (CPRA), the project is intended to reintroduce freshwater and sediment from the Mississippi River to the Barataria Basin to build, sustain, and maintain land in an area that is experiencing extreme land loss. The project is designed to reconnect the Mississippi River to its wetlands to protect some of the most vulnerable residents in the state, in addition to sustaining the ecosystem and wildlife on the coast. This area is also one of the most affected by the 2010 Deepwater Horizon oil spill, and this project is intended to remediate associated damage.

Past Issues

Originally posted to the Permitting Dashboard as a FAST-41 covered project in 2017, this project was first conceived as part of a U.S. Army Corps of Engineers feasibility study in 1984. The conclusion of the permitting process brings to fruition this effort to counteract decades of land loss and environmental instability for local residents. CPRA plans to begin construction in 2023, pending the approval of funding by the Louisiana Trustee Implementation Group, the agency charged with restoring Louisiana's natural resources after the Deepwater Horizon oil spill.

The Permitting Council Office of the Executive Director had the opportunity to tour the Mid-Barataria Sediment Diversion project site last spring, and it was eye opening to see firsthand how this project could help restore the LA coastline. Congratulations to Governor John Bel Edwards and the Louisiana CPRA for their efforts to restore the LA coastline.

Permitting Council Executive Director Releases Fourth Fiscal Quarter Agency Performance Report

Permitting Council Executive Director Christine Harada released the Executive Director's fourth fiscal quarter Agency Performance Report for 2022 in December. Required by the Bipartisan Infrastructure Law (BIL), this report assesses agency compliance with provisions of Title 41 of the Fixing America's Surface Transportation Act (FAST-41) and highlights implementation of revisions made to the FAST-41 Data Management Guide (DMG) as to implement the BIL.

This year was one of evolution for the Permitting Council, after passage of the BIL led to substantial updates to the operating procedures for FAST-41 covered projects. This quarterly report is the first since agencies have had a full reporting period under the updated DMG that went into effect in July and showcases a system in transition as Federal agencies work to meet the new statutory requirements.

Highlights of this report include the submission of three infrastructure projects to FAST-41 coverage and upcoming changes to simplify the submission process for the CPP certification process to support agency FAST-41 implementation and streamline Permitting Dashboard operation.

During the fourth fiscal quarter of 2022, there were 26 active FAST-41 covered projects on the Permitting Dashboard, with the majority in the offshore wind, solar, and other renewable energy sectors. Federally Recognized Tribes to Receive Groundbreaking Investment to Aid in FAST-41 Infrastructure Project Permitting Reviews

The Permitting Council is excited to announce the allocation of \$5 million in funding to be made available to Federally recognized Tribes to enhance Tribal engagement in the environmental review and authorization process for FAST-41 projects. These funds are an initial investment from the Permitting Council's \$350 million dollar Inflation Reduction Act funding and are a significant step in realizing the once-in-a-generation infrastructure goals of the Biden-Harris Administration.

Tribal participation in the review of projects that require Federal authorization approval are a key element to the environmental review and permitting process, yet Tribes often face capacity issues such as limited staffing and funds to provide technical input on planned projects.

Past Issues

Reviews of projects that may span across multiple agency jurisdictions and areas of oversight can create lengthy, time-consuming review processes that demand significant time and resources from Tribes. Increasing Tribal capacity to participate in the environmental review and authorization process is critical to ensuring our Nation is building sound infrastructure, and these funds will assist Tribes in obtaining the expertise and resources needed.

In order to assess the scope of needs and develop criteria for transferring funds, the Permitting Council Executive Director is inviting Tribes to engage in Nation-to-Nation consultation. The feedback given during consultation will assist the Permitting Council Executive Director in developing the criteria of eligible activities and capacity building tools that can be funded.

The Permitting Council Executive Director will evaluate the need for further Tribal funding after further consultation with Tribes.
